The role of National Contact Points is to further the effectiveness of the OECD Guidelines for Multinational Enterprises (the Guidelines) by undertaking promotional activities, handling enquiries and contributing to the resolution of issues that arise from the alleged non-observance of the Guidelines in specific instances by individual companies. NCPs will operate in accordance with core criteria of visibility, accessibility, transparency and accountability to further the objective of functional equivalence.

National Contact Points must regularly report to the OECD Investment Committee on the nature and results of their activities to further the effectiveness of the Guidelines including implementation activities in specific instances.

This Common Reporting Framework, based on the Implementation Procedures of the Guidelines, assists NCPs in the preparation of these reports. The information provided by NCPs is the basis for the Annual Report to the OECD Council on the Guidelines for Multinational Enterprises. It is also used to produce Annual reports of individual NCPs (NCP Annual reports).

¹ Until 2014, the reporting period for NCPs covered activities undertaken from June to June. From 2015 the reporting period will cover the period from January to December of each year. For practical reasons, the 2015 reporting period will also cover activities between June and December 2014.

The German NCP is based in the Federal Ministry for Economic Affairs and Energy acting in coordination with other ministries. The Ministerial Group for the OECD Guidelines in Germany brings together representatives from those federal ministries in Germany that are deemed to have a particular interest in the Guidelines. The "Working Party" discusses (a) current issues relating to the OECD guidelines, (b) how to improve the Dissemination of the Guidelines and (c) the working method of the National Contact Point.

The Guidelines appear on the webpage www.csringermany.de of the Federal Ministry of Labour and Social Affairs. It is the central page for the comprehensive action plan of the Federal Government to foster CSR in Germany and contains CSRrelated activities of all ministries. The regularly updated website of the German NCP is maintained and is easily found in the internet if the Guidelines are looked for in the context of Germany. It includes comprehensive information on the NCP.

Moreover, to give a short overview about the Guidelines and their implementation a short leaflet "OECDLeitsätze für multinationale Unternehmen – Empfehlungen für verantwortungsvolles unternehmerisches Handeln in einem Globalen Kontext und Nationale Kontaktstelle" gives a summary introduction to the Guidelines and its purposes and functioning. This leaflet has been revised in 2014 taking into account the opinions of the "Working Party on the OECD Guidelines".

Further explanations of the nature and handling of "specific instances" in Germany are provided in the "Procedural Notes" for the complaints procedure, which is also available on the NCPWebsite.

This "Procedural note" has also been revised in 2014 taking into account the opinions of the "Working Party on the OECD Guidelines". The German NCP is committed in the G7 process to the peer review and peer learning of the NCPs in the context of responsibility in supply chains and supported the Ministry of Labour and Social Affairs that is in charge for that part of the G7 process in its activities.

The NCP also supports and helps coordinating any outreach initiative for the further promotion and adherence of the Guidelines through developmental policy tools. Any related topic of the Ministry for Economic Affairs and Energy is tried to be linked publicly with the Guidelines.

The NCP relates to these instruments, as stated above, as it is part of the governmental action plan on CSR. The instruments should be seen as mutually reinforcing. The Federal Government emphasizes the importance of all three international, government backed instruments (OECD Guidelines, ILO Tripartite Declaration and UN Global Compact) wherever suitable, e.g. in the context of G8/G20. Promotion efforts by the respective agencies often comprise promotion of the other instruments. ILO standards are related to the interpretation and updating of the OECD Guidelines. Other instruments, like the Global Reporting Initiative, can help companies to implement the OECD Guidelines, especially after the update.

The NCP website had been opened in total 7381 times in the period beginning of July 2014 to the end of July 2015 (6554 German webpage, 827 English website). There were 5094 visitors of the German website and 707 visitors of the English website.

The NCP follows the discussion of Responsible Mineral Supply Chains and works closely with the responsible department (BGA Federal Institute for Geosciences and Natural Resources) that is also part of the Ministry of Economic Affairs and Energy. The BGA initiated and supported with regards to contend one session of the ICGLROECDUN Forums on "Responsible Mineral Supply Chains Forum" (2014/2015). In this context a study was conducted with the title "Assessing and Enhancing the Contribution of Small and Mediumscale Enterprises to Due Diligence for Responsible Mineral Supply Chains" financed by the Federal Ministry of Economic Cooperation and Development (that is part of the Interministerial Steering Group) The study will be published on the OECDwebsite.

Furthermore BGA is responsible for the implementation of the OECD guideline on due diligence for responsible supply chains of minerals from conflict affected and high risk areas.

Developing guidance at the national level – The NCP developed so called "procedural guidelines" to inform about the procedure of specific instances at the German NCP in general, but no guidance explicitly related to the topics mentioned above. However in the context of a specific complaint regarding responsibilities of two textile trading companies the NCP explicitly expressed its expectations on key aspects of how textile companies comply with due diligence recommendations.

In the textile and garment sector the Federal Ministry of Economic Cooperation and Development, which is part of the ministerial group, initiated a "textile pact" that builds on the OECD Guidelines

Horizontal learning activities:

On September 14th, the German NCP organized the "Second Regional Meeting for Central European National Contact Points" in Berlin. Representatives from the NCPs in Austria, Switzerland, Slovenia and the Czech Republic met in the Federal Ministry of Economic Affairs and Energy to exchange experiences. The participants discussed due diligence and supply chains, specific instances, cooperation between NCPs, promotion of NCP activities, how to behave with media campaigning, etc.

Cohosting events: The German NCP lead one of the NCP peer learning sessions on the Annual Meeting of the NCP's.

Cooperation in handling specific instances: The German NCP cooperated in several specific instances with other NCP, e.g. with the US NCP and the Turkish NCP in specific instances and the Polish NCP in handling a case with a German multinational enterprise

Mentoring/capacity building events: The German NCP took part in the Peer Review in Denmark and accompanied the Secretariat to Peking
